Inquiries of the Ministry

wants to take the course of removing a statement of that kind from the record because it was out of order is another matter, and it would be only as a result of a decision of the house that I would take that responsibility.

Mr. Hees: All I was doing, Mr. Speaker, was pointing out something that is obviously true, as is apparent every time we hear these statements made in the house.

Mr. Speaker: Order.

Hon. L. B. Pearson (Leader of the Opposition): Mr. Speaker, may I ask the Minister of Trade and Commerce whether he has any comment to a make on a report in a recent edition of the *Financial Post* attributed to Ottawa trade officials, presumably officials of the minister's department, to the effect that no export licence is required by a Canadian manufacturer to ship to Cuba if the products are non-strategic and are made in Canada.

Mr. Hees: Mr. Speaker, there are certain export control lists with which I have dealt in the house at some length and if products are not on any of those export control lists then a licence is not required.

Hon. J. W. Pickersgill (Bonavista-Twillingate): Mr. Speaker, I wish to direct a supplementary question to the minister and ask whether export credit insurance is available for these cash transactions with Cuban importers.

Mr. Hees: Mr. Speaker, export credit insurance has not been requested by the buyers who came from Cuba. As I pointed out on several occasions, these transactions are cash transactions, engaged in between the Cuban buyers and the Canadian producers. The government does not enter into them in any way, shape or form.

Mr. G. H. Aiken (Parry Sound-Muskoka): Mr. Speaker, I have a question for the Minister of Trade and Commerce. Has the minister learned of any country other than the United States which has placed an embargo on Cuban goods?

Mr. Hees: I am not aware of any other country that has done so, Mr. Speaker. It may interest the house to know that the United States is almost daily exporting large quantities of food to Cuba.
