RHODESIA—REPORTED STATEMENTS BY COM-MONWEALTH SECRETARY GENERAL

Mr. Diefenbaker: Mr. Speaker, I could not be more in agreement, that it warrants reading; but an answer from the government regarding this statement is also warranted.

Mr. Martin (Essex East): Mr. Speaker, so there will be no misunderstanding, when I said it would warrant reading I had in mind that anything Mr. Smith might say would deserve very serious study, because we all regard him as one who has distinguished himself in the performance of his responsibilities as a foreign service diplomat and, by virtue of the office he now holds in the commonwealth, we would want to attach to what he says the consideration which his utterances deserve.
