## CONTROLS ON AMPHETAMINE-TYPE STIMULANTS

#### Question No. 1,318-Mr. Comeau:

Did Canada refuse to support the efforts of Sweden to impose strict controls, through the United Nations Narcotics Commission, on amphetamine-type stimulants and, if so, for what reason?

Hon. John C. Munro (Minister of National Health and Welfare): No. On the contrary, the Swedish Delegation withdrew its resolution on this subject in favour of an alternative resolution spnsored by Canada, Federal Republic of Germany, France, Mexico, Peru, Switzerland, UAR, United Kingdom and the United States of America which was subsequently adopted by the Narcotic Commission. Canada's support of the Swedish efforts is reflected in the resolution that was adopted.

## IMPORTS OF BOOTS AND SHOES FROM CZECHOSLOVAKIA

# Question No. 1,320—Mr. Lambert (Edmonton West):

- 1. Did the Shoe Manufacturers' Association of Canada complain to the Department of National Revenue on March 7, 1968, and from time to time in the interval, concerning the importation in 1968 and earlier of leather work boots and shoes from Czechoslovakia and Poland at allegedly unfair prices which might constitute dumping?
- 2. If so, what action has been taken to investigate the validity of the complaints and with what results?
- 3. Has there been a determination that dumping has taken place and, if so (a) to what extent (b) what further action is thereby contemplated?
- 4. If the complaint of dumping has not been substantiated, what are the reasons for rejecting the complaint?
- 5. If no decision has yet been reached, when is one anticipated?

## Questions

Hon. Jean-Pierre Côté (Minister of National Revenue): 1. Yes.

- 2. With respect to Czechoslovakia, investigation revealed undervaluation and values were established under section 38 of the Customs Act. This resulted in a decrease in importations. No action was taken against importations from Poland because of the small quantities involved.
- 3, 4 and 5. In addition to the above another complaint was recently received from the Shoe Manufacturers' Association of Canada in connection with leather boots and shoes for work and sports wear from Romania and Poland alleging injurious dumping. The complaint was accepted on February 4, 1969, and a formal investigation initiated under the new Anti-dumping Act.
