Hon. members are well aware that the matter of summer employment for students has been brought to the attention of the House on a number of occasions in recent weeks. In particular, a motion similar to that now before us was proposed on May 14 by the hon, member for Nanaimo-Cowichan-The Islands. The ruling of the Chair on that occasion read in part as follows:

In so far as the reference to the problem of student employment during the summer months is concerned, it is hardly necessary for me to remind hon, members that a debate on this very subject took place on Friday last, when a supply motion was presented to the House by the hon. member for Edmonton Centre.

In view of the fact that there has already been a special debate in the House on this very subject, considering that it has been the subject of a number of interventions by hon. members since then, and taking into account the statement made on motions by the Minister of Manpower and Immigration which has been followed by the interesting and constructive comments of hon. members speaking on behalf of the parties in opposition, including the statement made by the hon. member for Calgary North, I would not think that I am at liberty at this time to put to the House the motion proposed by the hon. member.
