SALARIES AND DUTIES OF SECTION HEADS IN ADMINISTRATIVE SERVICES BRANCH, NATIONAL RESEARCH COUNCIL

Question No. 499—Mr. Holmes:

1. What are the (a) present salary ranges (b) official duties assigned to each of the following Section Heads in the Administrative Services Branch of the National Research Council (i) Central Administrative Services (ii) Plant Engineering Services?

2. (a) How many persons are presently employed by each section of the Administrative Services Branch (b) what is the salary range for persons employed by these sections?

3. (a) What was the overall budget, including grants, for the Administrative Services Branch for the fiscal year 1973 (b) what percentage of this budget was used to pay salaries for the Administrative Services Branch?

Hon. C. M. Drury (Minister of State for Science and Technology): In so far as the National Research Council of Canada is concerned, the answer is as follows: 1. (a) Salary range for head of: (i) Central Administrative Services, \$24,535 to \$27,811; *(ii) Plant Engineering Services Branch, \$30,250 to \$34,500; (b)(i) Under direction, the head of Central Administrative Services is responsible for providing central administrative services in areas such as property management, duplicating service, central filing procurement liaison and conference services, and for providing advice to NRC management on administrative problems; (ii) Under direction, the head of the Plant Engineering Service branch is responsible for the co-ordination of capital construction programs, the provision of engineering and craft support with respect to plant services, facilities and utilities, and the provision of building maintenance.

2. (a)(i) 130; (ii) 255. (b)(i) \$4,978 to \$27,811; (ii) \$6,389 to \$34,500.

3. (a)(i) \$2,787,000; (ii) \$4,940,000. (b)(i) 40 per cent; (ii) 42 per cent.

*Following a reorganization in 1973, Plant Engineering Services became a separate branch.

At the time a landed immigrant first registers with a Canadian Manpower Centre or engages in insurable employment, he becomes a member of the Canadian labour force and as such, is indistinguishable for statistical purposes from any other member of Canada's labour force. Unemployment insurance benefits which are paid to unemployed members of Canada's labour force are based on a recipient's record of attachment to insurable employment and entitlement to benefits rather than on length of residence in Canada or citizenship considerations.

In the last year for which the information is available, how many public servants in the Department of National Defence who received a gross remuneration in excess of \$20,000 also received a veteran's pension in excess of (a) \$5,000 per year (b) \$10,000 per year?

Hon. James Richardson (Minister of National Defence): The information requested is not readily available and could not be obtained without additional personnel and additional cost.

CANADA WORLD YOUTH ORGANIZATION

Question No. 542—Mr. Schellenberger:

1. Is Canada World Youth Organization presently funded by the government and, if so (a) to what extent is the funding (b) what criteria are used as to age requirements of group leaders or chaperons, their maturity, capability and experience?

2. Is the budget scrutinized in order to eliminate certain wasteful and unnecessary expenditures such as excessive long distance calls and travel or is the budget left to the discretion of the group leader?

Hon. Mitchell Sharp (President of the Privy Council): I am informed by the Department of the Secretary of State and the Canadian International Development Agency as follows: 1. (a) \$400,000 was funded to Canada World Youth from the 1974-75 Secretary of State fiscal budget to cover the final phase of the 1973-74 Canada World Youth program. The Canada World Youth Organization (C.W.Y.), is presently funded by the Canadian International Development Agency which has signed a service contract with this organization to provide \$2.8 million for year III of C.W.Y.'s
