not very deeply concerned about unemployment, that every unemployed person is a matter of concern. We do not have a certain figure that unemployment will reach in the future where we become concerned. We are concerned now, and we are doing everything within our power to assist, through the various programs that have been announced in the past month by various ministers. In housing, we have increased rental units financing that will create an additional 40,000 jobs. We have expanded the operation of Sections 37 and 38 of the unemployment insurance fund that will help probably an equivalent number of workers in the country to have jobs.

Miss MacDonald: 1,200,000 unemployed.

Mr. MacEachen: Through the Minister of Fisheries and Oceans we have established programs that will provide employment for, I think, about 25,000 to 40,000 jobs in that industry.

Miss MacDonald: This is the rhetoric.

Mr. MacEachen: We have increased our training programs up to a sum of \$1 billion in order to meet the training needs of persons in Canada. We are doing everything possible within the means at our disposal to assist the unemployed people of Canada. We will continue to do that and we are not waiting for some figure in the future that will oblige us to take action. We are taking action now.

Some hon. Members: Hear, hear!

NEGOTIATIONS OVER IMPORTS OF JAPANESE VEHICLES

Mr. Otto Jelinek (Halton): Madam Speaker, my question is directed to the Minister of State for International Trade. He should know that one third of all automotive assembly employees in Canada have either lost jobs or have been laid off. And he should know also that 40 per cent of Canadians working in the auto parts sector have lost their jobs as of today. Yet the minister has failed to curb the flow of Japanese imports into Canada; he has failed to negotiate a fair deal with Japan; he has failed to negotiate fair Canadian content regulations in offshore imports into Canada.

How much longer does the government intend to continue to negotiate, while jobs are being lost in Canada? How many more lost jobs will it take before the government takes the necessary unilateral action to stop the flow of Japanese imports into this country and save Japanese jobs?

Hon. Ed Lumley (Minister of State (International Trade)): Madam Speaker, I think the hon. member meant to say "save Canadian jobs", not Japanese jobs.

Some hon. Members: Oh, oh!

Mr. Lumley: Madam Speaker, the hon. member will be the first member to know when we strike a very positive relationship with the Japanese concerning the automobile industry.

RATIONALIZATION OF RUBBER PRODUCTION FACILITIES
