ITALIAN EARTHQUAKE VICTIMS—PROPOSED ESTABLISHMENT OF RECEPTION CENTRES IN CANADA—MOTION UNDER S.O. 43

Mr. Gordon Gilchrist (Scarborough East): Madam Speaker, I too rise under the provisions of Standing Order 43 on a matter of urgent, pressing and, I hope, compassionate necessity. In light of the statement last Wednesday by the Minister of Employment and Immigration that he had instructed our embassy in Rome to process immediately applications for immigrant status from people in the Italian provinces affected by the recent disastrous earthquake, and that his department is working with the Department of National Health and Welfare and the RCMP to waive requirements for the normal medical and security checks which can later be conducted in Canada, I move, seconded by the hon. member for Burlington (Mr. Kempling):

That, in addition to any special arrangements made in Italy, special reception centres be immediately established in Canada along the lines of those provided for the Vietnamese refugees last year where medical and administrative require-
