FERMI II NUCLEAR REACTOR—REVIEW PROCESS

Mr. Steven W. Langdon (Essex—Windsor): Mr. Speaker, I have a petition from 250 petitioners drawn from all parts of the constituency, particularly from Amherstburg, La Salle, Malden, Harrow and southern parts of Essex—Windsor. They are deeply concerned with respect to the Fermi II nuclear plant which has a terrible safety record. They suggest that it poses a clear and present danger to their lives and their property. Due to the abysmal record of accidents at the plant, they petition the Government to take active measures to ensure that a joint procedure is established to review this, involving both Canadians and Americans, before Fermi II is permitted to go to full operation.

REQUEST FOR TOUGH LEGISLATION DEALING WITH PORNOGRAPHY

Mr. John Reimer (Kitchener): Mr. Speaker, it is a pleasure for me to present a petition signed by 306 residents of Kitchener and the Waterloo region. These 306 signatures added to the 1,325 which I presented on August 19, brings the total number of signatures to 1,631 petitioning the Government to bring forward its tough legislation against pornography.

The petitioners point out that they depend for safety on those lighthouses and are absolutely opposed to their destaffing and
