FINANCE AND ECONOMIC AFFAIRS—NINETEENTH REPORT OF STANDING COMMITTEE

Mr. Don Blenkarn (Mississauga South): Mr. Speaker, I have the privilege of presenting the nineteenth report of the Standing Committee on Finance and Economic Affairs, in both official languages. The report recommends substantial changes to the Bank Act and regulations. Later this morning, a Private Members' Bill will be introduced complying with the terms of the report, and introducing an appropriate Bill.

The Bill will deal with how bank charges are to be imposed. It will limit the ability to impose charges under certain circumstances and will provide stiff penalties for non-compliance with the Bank Act.

BANK ACT

I would like to indicate that the regulations in the Bill will allow the prohibition of the common practice of having consumers waive their consumer rights when they open bank accounts. It will also allow the Government to set disclosure standards for future banking practices as well as prohibit certain bank service charges which the committee unanimously feels are not in the public interest.

I would like to thank all the Members of the committee, both government Members and Opposition, for their support with respect to this Bill.
