A. Campbell to England to communicate specially on the subject with Her Majesty's Government - - -	34
20	8 July, 1870 - - - (Received 9th July.) (Telegram.) (7375)	Secret and Confidential.—Fishery Question.—"My Ministers have consented to amend their special Instructions under protest. They have, however, adopted a strong remonstrance to accompany the concession, which they fear endangers their Ministerial existence" - - - - -	35
21	(Received 8 July, 1870) (Telegram.) (7376)	Fisheries.—"The special Instructions to the Marine Police have been brought into complete accordance with those issued by the Admiralty. The amendments are dated 27th June last. Despatch will be sent by mail of July 16th" - - - - -	35
22	6 July, 1870 (No. 154) (7997)	Instructions to Mr. Campbell in reference to Fishery Question. Transmits copy of Minute of Privy Council covering Memoranda for Mr. Campbell's guidance in bringing the subject before Her Majesty's Government - - - - -	35

27	28 July, 1870 (No. 175) (8537)	Capture of two American fishing-vessels by Canadian Police schooners. Explains inability to forward depositions in this matter by present mail, but expresses opinion that the Canadian Police Authorities had right on their side - - - - -	53
28	2 Aug. 1870 (No. 177) (8833)	Seizure of the American schooners "J. H. Nickerson" and "Wompatuck" and others. Transmits documents detailing the action of the Canadian Government and its Officers in reference to. Care has been taken to furnish Mr. Thornton with full information - - - - -	53
