THE ESTIMATES.

The estimates recently submitted by the Minister of Finance are rather startling. The aggregate for next year approaches very nearly to \$30,000,000, and although we have no doubt whatever that the Minister will be able to show ways and means amply sufficient to provide for them, yet it must be borne in mind that these are obtained by heavy taxation on the people, and that the time cannot be far distant when we shall have to face another period of depression, when most assuredly the revenue will fall off. We have no intention at present to discuss the details of the estimates, preferring to wait the discussion which will take place in the House when they are subjected to the criticism of the Committee of the Whole.
