Minister of Agriculture. I should like to ask whether the government has any plans to subsidize the corn growers of southwestern Ontario who are suffering from a 25 cent to 30 cent per bushel decrease in price this year. This would be a subsidy similar to the one offered the western wheat growers.

Hon. J. J. Greene (Minister of Agriculture): Mr. Speaker, I do not believe the analogy drawn by the hon. gentleman is correct. Certainly at the present time there are no plans along the lines he has indicated.

INQUIRY OF THE MINISTRY

Mr. Terence Nugent (Edmonton-Strathcona): Mr. Speaker, I have a question for the right hon. Prime Minister. I wonder whether the Prime Minister can advise the house if he has any plans to cope with the present crisis in the Department of Transport. The crisis I refer to is brought about by the appointment of the hon, member for Trinity as Minister of Transport.

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, I suggest the crisis is only in my hon. friend's mind.

SHIPBUILDING

PAYMENT OF SUBSIDIES ON FISHING VESSEL CONSTRUCTION

On the orders of the day:

Mr. J. O. Bower (Shelburne-Yarmouth-Clare): Mr. Speaker, I have a question for the Minister of Fisheries. It is one of import and urgency to at least six provinces in Canada. I should like to ask the minister whether the government has established as policy the cessation of building subsidies on fishing vessels.

Hon. H.-J. Robichaud (Minister of Fisheries): No, Mr. Speaker.

Mr. Bower: I have a supplementary question. I should like to ask the minister why then are subsidies not being granted on the building of fishing vessels in Nova Scotia?

Mr. Robichaud: As has been the case in the past, subsidies have been granted as soon as the applications are received and processed. If there have been any delays the hon. member may find out they have not been altogether the fault of the federal Department of Fisheries.
