**BUSINESS OF THE HOUSE**

**Mr. Baker (Grenville-Carleton):** Mr. Speaker, a few days ago the government indicated that they intended to proceed with the peace and security legislation next Monday. I wonder if the President of the Privy Council could tell us today what he contemplates in terms of government business for the balance of this week prior to the debate on the other legislation.

**Mr. Sharp:** Mr. Speaker, today we will continue with debate on second reading of Bill C-68. This will be the tenth day of debate on second reading, and I am hopeful it is now coming to a close. When it is completed, we will call a number of items on the order paper which I hope are not very controversial matters. We will call report stage of Bill C-61, the Senate amendments to Bill S-10, and the bill on motor vehicle tires, Bill S-8. There have been some changes in the arrangements for handling the administrative side under this bill, and I hope it will now receive quick assent. Then we will call Bill C-86, veterans' insurance. At a convenient time I am also ready to meet the convenience of members of the Progressive Conservative party on Bill C-82. If there is any problem about the timing of a vote on the completion of the debate on second reading of Bill C-68, we are quite ready to meet the convenience of opposition members.

**Mr. Kempling:** I rise on a point of order, Mr. Speaker. Regarding Bill S-8, if the President of the Privy Council could communicate to us the contemplated changes, it might expedite passage of this bill as we could discuss the changes with our people.

**Mr. Sharp:** Mr. Speaker, I shall be happy to do so.
