Child Abuse Study—The study is being sponsored by the Social Service Programs Branch of Health and Welfare in response to the recommendations made by the Federal-Provincial Consultation on Child Abuse held in Toronto in April, 1978; the recommendations made by the Standing Committee on Health, Welfare and Social Affairs in 1976; and as part of the federal commitment to the International Year of the Child. The study is headed by Corinne Robertshaw, a lawyer and senior executive on secondment from the Department of Consumer and Corporate Affairs. All provinces and territories were consulted prior to commencing the study. Findings and recommendations are being discussed with provincial/territorial officials and with experts in the private sector.

HOUSING FOR NATIVE PEOPLE

Question No. 651—Mr. Howie:

From January 1, 1978, what amount was (a) loaned (b) granted for new housing units for native people in New Brunswick?

Hon. Paul J. Cosgrove (Minister of Public Works): I am advised by Canada Mortgage and Housing Corporation as

follows: (a) Under the Rural and Native Housing Program, loans totalling \$10,908,000 have been committed for new housing units in New Brunswick between January 1, 1978, and April 30, 1980. This amount represents the federal government's 75 per cent share of capital costs, and does not include the provincial government's 25 per cent share.

(b) No grants are provided for the construction of new housing under the Rural and Native Housing Program.

NOTE: The above figures represent housing delivered to both native and non-native clients in rural areas.

Question No. 652—Mr. Howie:

From January 1, 1978, how many new units of housing have been constructed for native people in New Brunswick?

Hon. Paul J. Cosgrove (Minister of Public Works): I am advised by Canada Mortgage and Housing Corporation as follows: a total of 367 new housing units have been constructed/committed in New Brunswick under the Rural and Native Housing Program during the period January 1, 1978, and April 30, 1980. Approximately 110 units were delivered specifically to native clients.

Question No. 653—Mr. Howie:

From January 1, 1978, how many existing housing units for native people in New Brunswick have been repaired or improved by CMHC funding?

Hon. Paul J. Cosgrove (Minister of Public Works): I am advised by Canada Mortgage and Housing Corporation as follows: under the Rural Residential Rehabilitation Assistance Program (Rural RRAP), 3,689 units have been rehabilitated in New Brunswick between January 1, 1978, and April 30, 1980. A further 55 units on-reserve in New Brunswick have been rehabilitated during the same period. Apart from those 55 units on-reserve, no breakdown of the 3,689 Rural RRAP units, as to native/non-native clients serviced by the program, is available.

In addition, approximately 30 units have been improved under the Emergency Repair Program in New Brunswick since January 1, 1978.

Question No. 654—Mr. Howie:

From January 1, 1978, what amount was (a) loaned (b) granted for the repair or improvement of existing housing accommodation for native people in New Brunswick?

Hon. Paul J. Cosgrove (Minister of Public Works): I am advised by Canada Mortgage and Housing as follows:

(a) Under the Rural Residential Rehabilitation Assistance Program (Rural RRAP), \$15,897,000 has been committed in New Brunswick between January 1, 1978 and April 30, 1980. During the same period \$232,000 has been committed for on-reserve RRAP in New Brunswick.

NOTE: Under the provisions of Rural RRAP, a certain amount of the loan provided to a client may be forgiven, up to a maximum of \$3,750, depending on the client's adjusted income. Latest figures available, covering the period January
