#### GOODS AND SERVICES TAX

Mr. Gilbert Parent (Welland—St. Catharines—Thorold): Mr. Speaker, I have four petitions to present today concerning the GST. Inasmuch as it is possible that this will be rammed through the Senate against all the practices that have been in play there for a number of years, I feel it is imperative that these voices be heard one more time. Once again, the plea goes out to this government; please rescind this very unfair tax it is imposing upon the citizens of Canada.

Ms. Sheila Copps (Hamilton East): Mr. Speaker, I too rise to table a petition which joins the petitions of thousands of other Canadians protesting the GST and, in particular, protesting the government actions both here and in the other place in ramming the GST down the throats of Canadian taxpayers.

Mr. Peter Milliken (Kingston and the Islands): Mr. Speaker, I am pleased to rise to present a petition signed by numerous Canadians, many from the beautiful city of Saskatoon, Saskatchewan, who object to the goods and services tax and particularly its application to books.

They would be appalled at the actions of the government puppet in the chair of the other place who is seeking to ram this tax down the throats of Canadians.
