## **CANADA POST CORPORATION ACT**

## BILL TO AMEND-SECOND READING-DEBATE ADJOURNED

Hon. Michael A. Meighen, moved second reading of Bill C-73, to amend the Canada Post Corporation Act.

He said: Honourable senators, and Honourable Senator Frith in particular, I feel I owe you the same courtesy that I extended to my friend Senator Grimard to my left, which courtesy reminded me of you. Senator Frith: He never said anything unkind about you, as far as we know.

Senator Meighen: He did say:

When I was young, I was told, "You will see when you are 50." I am now 50 and I haven't seen a thing.

For those of you, honourable colleagues, who have reached 50, as I have, certainly you will relate to that.

I should also welcome Senator Barootes' comments and comment upon them, but since he is not here I will not make any reference to today's launch to which he referred, other than to welcome, on behalf of the Honourable Jean Charest, Kim Campbell into the race.

Senator Frith: It is not too plate so far.

Senator Meighen: Returning to the matter at hand, honourable colleagues, you will want to know that this bill will create a share structure to allow all 57,000 employees of Canada Post to participate in an employee share savings plan. It will make a positive contribution to labour relations at Canada Post by giving employees the opportunity to contribute to the prosperity of the organization and to share in that prosperity which they have helped to create.
