regulations are such that a difference is made between information and promotion. This difference concerned me so I raised the question and was told that the president of the CBC will discuss the problem with the directors of the corporation.

AREAS TO BENEFIT FROM \$150 MILLION JOB-CREATION PROGRAM

Mr. Robert Muir (Cape Breton-The Sydneys): Mr. Speaker, my question is for the Minister of Employment and Immigration. In view of the changes in the Unemployment Insurance Act which I am sure the minister realizes will create more difficulties in the Atlantic provinces, can the minister give a little more information regarding the announcement made by the Prime Minister and reiterated by the Minister of Finance about the \$150 million for job creation? That will be of great benefit, but I wonder if the minister would elaborate a little more as to what parts of the country that money will be going to and how much will be going to each area?

Hon. Bud Cullen (Minister of Employment and Immigration): Mr. Speaker, I cannot give the specifics the hon. member is calling for because that is at the initiative of the Minister of Finance. As Minister of Employment and Immigration, I have made my representations as to the manner in which I think that money could best be utilized in conjunction with tax benefits. Whether my suggestions will be followed I do not know. It is my view that the representations I make would be heavily weighted in favour of areas of high unemployment.

Mr. Muir: Mr. Speaker, I want to thank the minister for his answer. In light of the fact that at the moment there are between 3,000 and 4,000 applicants for employment at the Cape Breton Development Corporation—one place alone on Cape Breton Island—and in view of the fact that this minister has worked underground and has gone through the rigours of mining, would he educate the Minister of Industry, Trade and Commerce and ask him not to make derogatory remarks about Cape Breton miners and their work ethics?

SUGAR CONTENT OF BREAKFAST CEREALS—PROPOSED LABELLING REQUIREMENT—POSITION OF MANUFACTURERS

In August in a joint communique the Minister of National Health and Welfare and the Minister of Consumer and Corporate Affairs revealed that some of the leading breakfast cereals in the country were over half sugar.
