BRIGHTER LABOR SITUATION CAUSES ACTIVE TRADE

All But the Short Interests Encouraged by the Attitude of Organized Labor—Weekly Bank Statements Gave Further Upward Trend to Market.

New York, N.Y., Sept. 2.—Stocks were strong and moderately active throughout today's session, the trend of events over the triple holiday, especially the brighter labor situation, affording the financial community much satisfaction. The more conservative attitude of organized labor, pointing to a better understanding with the federal authorities and prospects of a long truce pending satisfactory adjustment of economic problems, encouraged all but the short interest. Another development of sentimental influence was the weekly bank statement, which wiped out the nominal deficit in actual reserves reported the week before and left a liberal total to the credit of that item. The international money market was again the one adverse or disquieting feature, sterling exchange forfeiting more of its recent recovery, with heaviness on francs and Italian remittances at a new point of depreciation. Dealings were considerably larger than at any period for almost a fortnight, although the buying centered very extensively in steel equipments, oils and motors, where gross gains extended from two to almost fourteen points. Crucible Steel led the list, other noteworthy features including Texas Company, Mexican and Pan-American petroleum, Studebaker, Stutz, Chandler, Maxwell and General Motors, Atlantic Gulf, American International, American Woolen, Hide and Leather. Preferred and the more popular food issues. Ralls were conspicuous for the strength of low grade shares, notably Texas and Pacific, Denver and Rio Grande Preferred and St. Paul and Metals scored moderate gains. Sales amounted to 1,100,000 shares. Firmness of international was the only feature of an otherwise irregular bond market, Liberty issues holding steady. Total sales, par value, were \$11,208,600. Old United States bonds were unchanged.

HEALEY WARNS LABOR IS BEHIND BOSTON POLICE

Boston, Aug. 26.—Police Commissioner Curtis, after hearing arguments by counsel for the police department for the principal officers and two other members of the newly formed police men's union, took under advisement today the case of the union men. They were tried before the commissioner on charges of having violated a department rule by joining the union. In connection with the union's efforts to obtain recognition by the department, Timothy Healey of New York, president of the International Brotherhood of stationary firemen and oilers, said here tonight that if the members of his organization asked permission to strike in support of the policemen he would grant sanction "by long distance telephone, as the telegraph would be too slow." The revolution with American freedom, said Mr. Healey, "started in Boston and unless Commissioner Curtis changes his tactics very soon the revolution for American industrial freedom will also start here, as organized labor is a unit in this fight of the policemen for their constitutional rights and the department that hampers beings deserve."

MONTREAL INLAND REVENUE OFFICE HAS BIGGEST MONTH

Amount Collected for August Exceeding Corresponding Month Last Year by \$700,000—Cigars, Cigarettes and Spirits Cause Increase.

Montreal, Sept. 2.—The biggest month in the history of the Inland Revenue office of the division of Montreal, stated Mr. J. A. Bernier, District Inspector, yesterday, in reporting the amount collected for the month of August. The amount taken was \$2,701,057.84, as compared with the amount of \$2,006,339.45 in the corresponding month last year. A considerable portion of this increase is due to the importation of spirits, which was about \$150,000 during August, while in the same month last year it was about \$100,000. At the same time the fact that these spirits were cleared through the division of Montreal does not indicate that they stopped here, for they were for distribution to many points in the country. The balance of the increase came in on cigars and cigarettes and tobacco. The trade in cigarettes especially is still very active, and shows no indication of diminishing, but rather the reverse. The last high water mark in the month of April, when the amount of \$2,575,000 was collected but it will be that the month of August topped that by another 26,000. The receipts at the Montreal Customs House for the month just closed also showed much brisance of trade and an increase compared with the same month of 1918. The total for the month of August just passed was \$3,191,463.25, as against \$2,527,533.45 for the month last year, or an increase of \$663,929.80 this year. As compared with the month of July of this year, however, the receipts for August show a falling off, but the interruption of shipping owing to strikes on the other side of the Atlantic, is to some extent responsible for decrease in imports.
