entitled, "an act to repeal certain parts of an act paffed in the fourteenth year of his Majefty's reign, entitled "an act for making more effectual provision for the government of the Province of Quebec, in North America, & to make further provision for the government of the faid province," and by the authority of the fame, That the faid act of the forty fifth year of his Ma jefty's reign, and every part thereof, and every clause, matter and thing there in contained, fhallbe and the fame is hereby continued.

II. And be it further enacted by the authority aforefaid, That the affignee of affignees of the nominee or nominees of the crown to lands in this Province. who is or are dead, or who have left this Province before the paffing of this act, without having obtained his Majefty's letters patent for fuch lands in his. her or their lifetimes, or before he, the or they did leave this province, may respectively bring their claim or claims for the faid lands before the commif. fioners hereinafter to be appointed, who shall and may and they are hereby authorized to hear and determine the claim or claims of fuch affigure or alfignees, and to report thereupon to the Governor, Lieutenant Governor, or Perfon Administering the Government, in council, in like manner and under the like regulations and reftrictions as are in and by the faid act passed in the forty fifth year of his Majefty's reign, and hereby continued, directed to be observed respecting the claim or claims of the heir or heirs, devisee or devisees of the nominee or nominees of the crown to lands, brought before the commiflioners under that act, & that it shall and may be lawful for the Governor. Lieutenant Governor, or perfon administering the government, in council, to iffue his Majefty's letters patent for the lot or lots, parcel or parcels of land specified in the faid report to or in truft for such person or persons, his, her or their heirs and affigns, as is or are therein declared, by the faid commissioners to be appointed under and by virtue of this act, to be the affignee or affignees of the nominee or nominees of the crown, as aforefaid, to fuch lot or lots, parcel or parcels of land; and that all and every the provisions, regulations, reftrictions, matters and things, which in and by the faid act of the forty-fifth year of his Majefty's reign, are enacted and contained, of and concerning, or in any wife touching or relating to the claim or claims of the heir or heirs, devifee or devices of the nominee or nominees of the crown, mentioned in that act, shall be and are hereby extended to the affignee or affignees of fuch nominee or nominees.

111. And be it further enacted by the authority aforefaid, That for the better procuring of evidence to be laid before the commiffioners to be appointed under this act, refpecting any claim or claims that may be brought before them by virtue thereof, it thall and may be lawful for the Governor, Lieutenant Governor, or perfon administering the government of this Province, for the time being, to appoint tome perfon in each and every diffrict of this Province to be a commiffioner for taking upon oath (which oath the faid commiffioners are hereby authorized to administer) the teitimony of any perfon or perform relative to fuch claim or claims to be brought before the faid commiffioners.

IV. And be it further chasted by the awh riv aforefaid, That if any perfon or perfons shall for wear nim, her or themicives before any such committioner, he, the or they shall on conviction thereof, he subject to all the pains and penalties of willul and corrupt perjury.
