Members and friends of the Society, whilst viewing this state of affairs with gratitude to Him from whom alone "all good counsels and just works" proceed, must also bear in mind that it is only in answer to our own prayers and exertions that a continuance of God's blessing can be looked for. The greater activity, which, since the extension of the episcopate, has prevailed in our colonial churches, has served to bring to light an accumulation of neglect and spiritual destitution, the existence of which was unknown before. At no time during the past years of the Society's existence, was there a more rigid economy in the administration of its funds; at no time were the calls upon it so numerous, so various, and so urgent. And at no time has God opened the hearts of His people to afford to it so liberal a support as at the present. "Let us not be weary in well doing." For that which has been accomplished is, indeed, but a portion of that which it is our duty to do to our own neglected countrymen and to the heathen whom God has placed under our influence.
