electoral district of Yukon, and it sets out what seem to me to be very convincing reasons. They say among other things:

That your petitioners prefer to have the representation of Mackenzie district to parliament postponed and to remain for the present without such representation rather than to have the district included with the electoral district of Yukon.

They go on to ask that the words "including the Mackenzie district of the Northwest Territories" in section 2 of Bill No. 18 be struck out.
