Mr. Simpson: A supplementary question, Mr. Speaker. Would the minister be prepared to look into such representations immediately in order to rectify this situation?

Mr. Pickersgill: That is done almost automatically in these matters.

Mr. Diefenbaker: "Almost" automatically.

COLLECTION OF SALES TAX ON CEN-TENNIAL PROJECTS

Mr. H. W. Herridge (Kootenay West): Mr. Speaker, in view of our approaching centennial, and to promote the spirit of unity in this house and in Canada, I wish to address a question to the Minister of Finance. Can the Minister of Finance explain why sales tax is charged on centennial projects which are entirely financed by grants from various levels of government?
