LABOUR RELATIONS

REQUEST FOR ASSURANCE OF AUTONOMOUS STATUS OF CANADIAN UNION

Mr. Frank Howard (Skeena): Mr. Speaker, I have a question for the Minister of Labour in relation to a matter I directed to his attention a few days ago. In order to refresh his memory may I say that my question has to do with the takeover of the International Brotherhood of Railways and Steamship Clerks, or the merger of that union with the Canadian Brotherhood of Railway Transport and General Workers. I have been looking forward to the minister's answer, particularly because of our concern for democracy and the maintenance of Canadian unions. Has the minister anything to say in respect of this situation?

Hon. Bryce S. Mackasey (Minister of Labour): Mr. Speaker, I have received certain letters from members of the C.B. of R.T. complaining that they have had little or no opportunity to express an opinion on this matter at the local level, or no opportunity to instruct delegates to the convention. I can only suggest to the unions involved in respect of the position they take regarding the rights of their members, that they should look at page 151 of the Woods task force report, with reference to the recommendations that a Bill of Rights be established for the average union member, in order that he may participate fully in union affairs.

SEALING—STEPS TO PREVENT DISSEMINATION OF FALSE ADVERTISING

If so, will the minister take steps to prevent the further propagation and dissemination of false and misleading advertising which will hurt further Canada's reputation abroad, and the sealing industry?

RESTRICTIONS IN SAINT JOHN HARBOUR AND

Mr. Bell: A supplementary question, Mr. Speaker. Will the minister give an undertaking to make a report this week on the result of these meetings before the season reaches a stage where relief would not be possible even if it were desirable?
