LOCAL INITIATIVES PROGRAM—PERSONNEL MAKING DECISIONS ON EXTENSION OF PROGRAMS—REQUEST FOR CONSULTATION WITH THOSE INVOLVED

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, my question is for the Minister of Manpower and Immigration regarding his statement earlier today. Who will make the decisions as to which LIP projects will be extended, and can the minister assure the House that the local people involved will be consulted regarding the projects?

Mr. Stanfield: Let's not get into that.

Hon. Bryce Mackasey (Minister of Manpower and Immigration): Mr. Speaker, the 5,000-odd programs that are already in existence, many of which will be phased out at the end of May, have been visited by representatives of the department and evaluated to the extent of 92 per cent. A committee, which is independent of the minister for obvious reasons, has evaluated the projects submitted from the very beginning and it is expected that this committee, based on its studies, will select the 1,200 particular projects. The concept is not the effect it will have on unemployment—that would be very simple as the criteria would be merely that the project should be labour-intensive—but rather the effect that the programs have on the quality of life in many parts of this country, particularly those projects, for instance, that render direct assistance to senior citizens-
