Inquiries of the Ministry

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, perhaps you had not realized it but, with all deference, I think this question is not within my competence. However, the answer is no.

AIRPORTS

COMPLETION OF NEW TERMINAL AT TORONTO INTERNATIONAL—DECISION ON SITE OF NEW FACILITY

Mr. Stanley Haidasz (Parkdale): Mr. Speaker, I should like to ask the Minister of Transport whether any extraor-

dinary steps have been taken to expedite the completion of the second terminal at the Toronto International Airport, and can the minister inform the House when we may expect a decision on the site for a second airport for Toronto and the neighbouring area?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, as to the first question, the situation is that we have changed the contract with the contracting company to employ a very substantial additional number of workers and increase the pace of the work over the winter. This will have the double objective of getting more people to work and getting the first section of the terminal open by April and the full terminal open by June. In regard to the second question, the answer is the same as I gave a week ago.

May I have the indulgence of the House to add to an answer I gave a few moments ago to the hon. member for Mackenzie, Mr. Speaker?

SUGGESTED CONTINUATION OF SERVICE TO SUMMERSIDE, P.E.I. BY EASTERN PROVINCIAL AIRLINES

In view of those circumstances it would not be proper for me to consult with the parties in advance of receiving the appeal. Given these new circumstances, I will look into the matter and see what I can do to accommodate the hon. member.
