REQUEST FOR STATEMENT ON MEASURES TO CREATE JOBS FOR THE UNEMPLOYED—MOTION UNDER S.O. 43 $\,$

Mr. Perrin Beatty (Wellington-Grey-Dufferin-Waterloo): Mr. Speaker, I rise under the provisions of Standing Order 43 to ask for the unanimous consent of the House to move a motion dealing with a matter of urgent and pressing necessity.

That this House regrets the government's failure to provide the stimulus needed to create jobs for Canada's unemployed, and particularly for young people who are unemployed, and instructs the Minister of Finance to make a statement on motions at the earliest opportunity disclosing what special measures the government intends to take to deal with this problem.

SUGGESTION BOARD REVIEW PROPOSED RATE INCREASE BY ONTARIO HYDRO—MOTION UNDER S.O. 43

NORTHERN CANADA POWER COMMISSION

As he also knows, these proposed increases will take effect only with the approval of the Cabinet. I should like the minister to tell us whether the cabinet intends to approve this unfair increase on the people of the northern territories.
