CALL FOR IMMEDIATE INTRODUCTION OF BUDGET—MOTION UNDER S.O. 43

Mr. Ray Hnatyshyn (Saskatoon-Biggar): Mr. Speaker, I rise, under the provisions of Standing Order 43, on a matter of urgent and pressing necessity. There has been no budget brought down by this government since March 31, 1977, despite the serious deterioration in the country's economy. Budgets are necessary for planning for Canadian business and taxpayers; budgets contain supporting information and documentation to substantiate projections, and uncertainty of taxation or incentives undermines business confidence and the taxpayers' forward-planning.

In view of this government's horrendous deficit covering current operating expenses, which means mortgaging our country and future generations as a testament to this government's incompetence, I move, seconded by the hon. member for York-Simcoe (Mr. Stevens):

That this House direct the Minister of Finance to immediately bring down a budget.

LAY-OFFS AT FIRESTONE'S CALGARY PLANT—MOTION UNDER S.O. 43

Firestone of Canada Ltd. has just laid off 110 workers at its Calgary plant, bringing the total number of lay-offs to 270 in the past year. Firestone had been given a 15-year grace period from city taxes in return for providing Calgarians with jobs. I therefore move, seconded by the hon. member for Broadview (Mr. Gilbert):

That this House condemns the Firestone company's refusal to co-operate with UIC officials and directs the Minister of Employment and Immigration to intervene on behalf of the workers at that plant.

ADMINISTRATION OF JUSTICE

REQUESTED ESTABLISHMENT OF OMBUDSMAN—MOTION UNDER S.O. 43

As the protection of the citizens should be the basic concern of any government, and as it also behaves the federal government to ensure the citizens better protection in their dealings with the state, I move, seconded by the hon. member for Roberval (Mr. Gauthier):

That this House call upon the Minister of Justice (Mr. Basford) to take all steps required, as soon as possible, to introduce a bill creating for Canada the office of a federal ombudsman, given the fact that present efforts by the government to determine how best to guarantee the citizens optimum protection in their dealings with the state are inadequate.
