THE BUDGET

INQUIRY WHETHER PROVISIONS WILL INCREASE LIVING COSTS

Mr. Ray Skelly (Comox-Powell River): Madam Speaker, my question again follows up on the news about the consumer price index today, and I would like to direct it to the Minister of Finance. There has been, as we all realize, a substantial increase in the annual inflation rate. We are looking now at a figure of 10.7 per cent. There has been a dramatic increase in the price of food, the rate of which is running at roughly 13 per cent, and a loss in purchasing power for most Canadian families, running at about \$1,400 a year. This has continued over a three-year period.

I wonder if the Minister of Finance would mind confirming for this House that when his budget is presented on October 28 we will find a dramatic increase again in the cost of living for all Canadians, including dramatic increases in the price of energy and substantial tax increases? Would the minister be prepared to confirm that we will not find relief from this burden and that in fact inflation will probably be out of control as a result of this new budget?

Hon. Allan J. MacEachen (Deputy Prime Minister and Minister of Finance): Madam Speaker, it is not possible for me to indicate now what measures will be in the budget, but I
