Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, I can only assume that a distinguished former university professor knows better than that. The facts remain as they have always been, that the Government of Canada can decide what it wants to put on the table and keep on the table, and the Government of the United States decides what it wants to put on the table and keep on the table. Nothing has changed.

Mr. Steven W. Langdon (Essex—Windsor): In that case, Mr. Speaker, if the Minister is prepared to talk—so, talk. Let me ask him if in fact he will act right now, unilaterally, and say, "Despite Mr. Murphy's comments yesterday, we are not prepared at any time, or in any way, to talk about social policy in the course of these free trade talks".

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, if the Hon. Member thinks that was tough talk, "he ain't seen nothing yet".

Some Hon. Members: Hear, hear!

Some Hon. Members: Oh, oh!

Mr. Clark (Yellowhead): I do not know what passes for tough talk in the New Democratic Party.

Look, Mr. Speaker, the question of social programs is not an issue in discussion on trade. The question of cultural programs is not an issue in discussions of trade. The question of the Auto Pact is not something we propose to raise or have result in a change in the system that we think is working perfectly well. That, by my calculation, is the one million two hundred and thirty-seventh time I have given that answer in the House of Commons, and I would hope that the New Democratic Party would get in touch quickly, by telephone, with the CLC to get some new questions.
