

sentenced has made arrangements with the lieutenant governor of the province of Ontario for the safe keeping of any such person in Ontario, and such arrangements have been communicated to the minister by the lieutenant governors of the provinces concerned, the minister shall, in the case of any such person, communicate, under the next preceding section, with the lieutenant governor of Ontario, who shall, in such cases, have all the powers thereby given.

Assuming that a convict belongs to, say Nova Scotia, and there is no asylum in connection with Dorchester penitentiary, then it would seem that lieutenant governor of Nova Scotia would have to make some arrangement with the lieutenant governor of Ontario in order to provide for the prisoner's maintenance in an asylum in Ontario.

Hon. Mr. SCOTT—The way it operates is this: During the term for which the convict has been sentenced, he is kept in the penitentiary, and at the expiration of his sentence, if it happens to be in the province of Ontario, he would be sent to the provincial asylum the moment his term of imprisonment there terminated.

Hon. Sir MACKENZIE BOWELL—Then he would finish the term of imprisonment in the Kingston asylum?

Hon. Mr. SCOTT—Yes, but in Manitoba and British Columbia he would have to go direct from them because they have no insane ward connected with either of them. In that case, the federal government pay the province \$1 a day.

The clause was adopted.

On clause 66,

66. Any convict who is furnished with money or with tickets for transportation in pursuance of the provisions of subsection 4 of section 70 and who uses the same for any other than the purpose intended is guilty of an offence and liable, on summary conviction, to imprisonment for a term not exceeding three months.

Hon Sir MACKENZIE BOWELL—What has led to the adoption of this clause?

Hon. Mr. SCOTT—A certain sum of money is given to the convicts when they leave, for the purpose of taking them to the particular part of the country to which they elect to go. If, instead of making the journey, a man spends that money in Kingston and gets drunk, he is liable to be taken up for it.

The clause was adopted.

On clause 70,

70. No convict, upon the termination of his sentence, or otherwise, shall be discharged from a penitentiary during the month of December, January or February, unless at his own request, but may remain in the penitentiary until the first day of March following the termination of his sentence; and no convict who, at the expiration of his sentence, is found to be suffering from any acute, dangerous, contagious or infectious disease shall be discharged unless and until in the opinion of the warden such discharge may safely be made; provided that a convict remaining from any cause in a penitentiary after the termination of his sentence, shall be under the same discipline and control as if his sentence were still unexpired.

Hon. Mr. SCOTT—Previously the time mentioned here covered five months instead of three. It was formerly November, December, January, February or March, but it has now been cut down to the three months mentioned.

The clause was adopted.

On schedule (a).

Hon. Mr. SCOTT—I have under my hand a statement showing increases and decreases as regards the Kingston penitentiary. The following is a list of the officials showing what changes have been made:
