GAGETOWN

Gagetown, Oct. 27.—Jack Clifford and Frank Langford, the two young men arrested at Burton on Sunday afternoon, and charged with breaking into the C.N.R. Station here on Saturday night, were brought before His Honor Judge Slipp, yesterday afternoon, having been taken to trial under the Speedy Trial's Act. Their case was taken up at two o'clock, and as both pleaded guilty, it was quickly concluded. His Honor passing a sentence of five years in Dorchester on each of them. The prisoners seemed quite unconcerned by the length of the sentence; in fact a smile flickered over the face of one of them. Possibly the icy wind and snow furrier which prevailed made Dorchester look like a comfortable haven during the winter. His Honor, in addressing the prisoners, said he hoped that during their term of imprisonment, they would resolve to lead more useful and industrious lives. Both prisoners are young men of about twenty-four or five years of age.
