SHIPMENTS THROUGH SAINT JOHN, N.B.—MOTION UNDER S.O. 43

**Mr. Bob Corbett (Fundy-Royal):** Madam Speaker, I rise to move a motion under the provisions of Standing Order 43. During the summer months the port of Saint John lies substantially idle and the dock workers are unemployed. A tremendous assistance to these workers could be provided by the government if they would use their good offices, in the same fashion as the Solicitor General (Mr. Kaplan), to urge the Wheat Board to divert just a few shipments through the port of Saint John during this period to benefit the workers. Therefore I move, seconded by the hon. member for Mississauga South (Mr. Blenkarn):

That the government not make a decision on this critical issue to workers in Saint John by refusing the motion but show their concern by agreeing to take it under consideration, by adopting it.

## ADMINISTRATION OF JUSTICE

CALL FOR DISMISSAL OF SOLICITOR GENERAL—MOTION UNDER S.O. 43

That this House urge the Prime Minister to do justice to all Canadians who believe in the rule of law by firing the Solicitor General forthwith, but that he ensure that this justice be tempered with mercy by firing the minister gently.

## EDUCATION

ASSISTANCE FOR POST-SECONDARY STUDENTS—MOTION UNDER S.O. 43

**Mr. Walter McLean (Waterloo):** Madam Speaker, I rise to move a motion under the provisions of Standing Order 43. Reports from student aid officials in six provinces indicate that the expenses of the average aid-receiving student still exceed his or her summer earnings, savings and/or government assistance by some 15 per cent, as first reported by the 1980 federal-provincial task force on student aid. Now, in the coming academic year, fee increases at Canadian universities will be between 10 per cent and 30 per cent. Therefore I move, seconded by the hon. member for Lethbridge-Foothills (Mr. Thacker):

That this House impress upon the Secretary of State, in light of his responsibility for post-secondary payments and the Canada Student Loan Program, the urgent need for immediate financial assistance for most Canadian post-secondary students, many of whom have little hope for summer employment.
