BASE METALS—REFERENCE TO UNION STATEMENT ON TARIFFS

On the orders of the day:

Mr. J. A. Byrne (Kootenay East): I should like to direct a question to the Minister of Finance. Has the minister's attention been drawn to a statement by the executive board of the international union of mine, mill and smelter workers, which represents 100,000 workers in the base metals industry? The statement reads in part as follows:

We declare the erection of barriers between the United States and Canada to prevent the free flow of non-ferrous metals is contrary to the interests of our membership and we therefore recommend that no tariff barriers be erected between our two countries.

Would the minister bring this important development to the attention of the United States authorities?

Hon. Donald M. Fleming (Minister of Finance): My hon, friend sent me a copy of this document headed "Statement on Tariffs" since coming into the house this morning. What it indicates is not a new situation at all. This parliament has control over the tariffs of this country. As to whatever tariffs the United States choose to impose upon the importation of non-ferrous metals from Canada into that country, of course that is a matter for the United States administration and congress. But in that respect I repeat what I have said so many times this session, namely that we have made strong and urgent representations to the United States against any such action on their part. The United States administration has not indicated latterly any final policy with regard to this year 1958, but they are very well aware of the views of this country.

Mr. Byrne: I have a supplementary question. I am sure the minister does not realize that this is a new development, that the unions in the United States had made representations to the tariff commission favouring the tariff. In my opinion this is a new development, and I was wondering whether the minister would bring it to the attention of the United States authorities.
