DISTRIBUTION OF PAMPHLET RESPECTING REHABILITATION LEGISLATION

On the orders of the day:

Mr. Samuel Boulanger (Drummond-Arthabaska): Mr. Speaker, I should like to put a question to the Minister of Agriculture. Could the minister inform us when he distributed the A.R.D.A. pamphlet and whether he has sent a copy to all the members?

Hon. Alvin Hamilton (Minister of Agriculture): Mr. Speaker, there has been no planned pattern of distribution. I sent copies to the various ministers of agriculture across Canada and to the heads of farm organizations as a basis on which they could make comments when I had my usual contact with them before second reading of the bill was moved. In the pamphlet it says that if further copies are requested they can be secured from the Canada Department of Agriculture. I should like to point out that not only the farm organizations but provincial governments as well have asked for them, including the government of Saskatchewan, which has asked for 2,500 copies.
