When we embark upon such negotiations concerning the establishment of diplomatic relations with any country we discuss the question of personnel and reciprocal arrangements. And these matters are part of the discussions going on now, or rather which have begun.

**Mr. Thompson (Red Deer):** My second supplementary question, Mr. Speaker, relates to the statement just made by the Prime Minister that negotiations are now taking place with Red China. Can the Prime Minister inform the house whether Canadian-Chinese discussions have in fact begun? Has the Chinese government replied to the invitation from Canada?

**Mr. Trudeau:** If the hon. member reads *Hansard*, Mr. Speaker, he will see that I said, "were going on now" and corrected this to "which had begun". As the Secretary of State for External Affairs indicated earlier this week, discussions have started and on-going steps will be reported in due course.

#### ACTION TO EXCLUDE REVOLUTIONARIES

**Right Hon. J. G. Diefenbaker (Prince Albert):** Mr. Speaker, I first brought up this matter on November 13. In the absence today of the Minister of Forestry and Rural Development, the Secretary of State and the Minister of Manpower and Immigration, I direct my question to the Prime Minister. It has to do with the necessity of the Canadian government taking action to keep out of Canada well recognized revolutionaries who are coming here and disturbing the peace in various universities and colleges. I ask, does the government intend to follow the course that was followed in the United Kingdom and also in France of keeping out individuals of communist inclination who advocate the overthrow of government by force. Secondly, in the case of students coming from foreign countries who, by their lawlessness here, undermine the rule of law, does the government intend to deport them to their own countries so that they will be able to do their work at home rather than in Canada. Their work here is to the detriment of our people.

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, if the right hon. gentleman has been waiting since November for an answer to his question perhaps he ought not to have asked it on a morning when the ministers he mentioned are not in the house to answer his question.

**Mr. Diefenbaker:** No, no. Because of recent events I wanted an opportunity to ask my question this morning.

**Mr. Trudeau:** The second part of the question was dealt with by the Minister of Manpower and Immigration one or two days ago. As to the first part of the question, the right
