Mr. Trudeau: I am quite sure they are aware of it, Mr. Speaker.

Mr. John Lundrigan (Gander-Twillingate): In view of the fact that the Prime Minister has indicated that this is now the No. 1 priority facing the nation, is he prepared to put his money where his adequate mouth is in this respect?

Mr. Speaker: Order, please. I suggest to the hon. member this type of question is quite unacceptable for many reasons.
