minorities in Quebec. There is none at all. The problem lies exclusively on the French-speaking side.

I think the attitude of my hon. friends from the Progressive Conservative and New Democratic parties is an indication of more huge difficulties in accepting a modest attempt at solving a national problem in Canada.

As for the government, I blame it because it deliberately tries to promote disorder in Quebec, by planning the establishment of bilingual districts in metropolitan Montreal as well as in other areas of the province. This is stupid, at a moment when we are fighting tooth and nail to save the French language and to get a true French-speaking management in Quebec. Mr. Speaker, there is no need to be so ridiculous and establish bilingual districts where they are absolutely not required.

I think I had to clarify this point. Mr. Speaker, we have indicated many times what we want. French Canadians do not want to get minor improvements here and there, what they want is a complete equality. Wherever you are in the country, it is not wrong to speak French and the federal government should provide its services in French anywhere. This is our minimum requirement and it must be met if we are to maintain Canada as it is.
