**Question No. 37—Mr. Cossitt:**

1. (a) What is the annual salary of Mr. Michael Pitfield, Clerk of the Privy Council and Secretary to the Cabinet (b) what is the total amount of remuneration he has received from the date of his appointment to the date the answer to this question is prepared (c) what is the total amount of all expenses, or anything

whatsoever, paid for from public funds for Mr. Pitfield up to the date this question is answered (d) has Mr. Pitfield made any trips away from Ottawa which were either paid for from public funds or which involved travel on government owned aircraft and, if so, for each trip (i) what were the dates involved (ii) what was the purpose (iii) what was the total cost (iv) what was the destination?

2. On what date was the answer to this question prepared?

**Right Hon. P. E. Trudeau (Prime Minister):** 1. (a) and (b) See reply to question 2984 answered February 6, 1976. (c) \$4,278.71 (January 8, 1975 to date). (d) Yes—none involved travel on government-owned aircraft. See statement following. Costs included in (c) above.

2. The Government takes responsibility for the answers it provides to questions on the Order Paper and for the process involved in reply to such questions. It is not appropriate therefore to provide information such as asked in this question about internal administrative workings.

MR. FRANK HORSFIELD

**Question No. 58—Mr. Cossitt:**

1. Were charges laid against Mr. Frank Horsfield presently of the Manpower and Immigration Regional Office in the City of Toronto on March 22, 1974 and, if so, what is a list of all charges involved?

2. Has any trial taken place and, if not (a) for what reason (b) on what date will the matter come to trial?

**Hon. Francis Fox (Solicitor General):** 1. On March 22, 1974, one charge under Section 324(1)(b), Criminal Code—Forgery was laid against Frank C. Horsfield. On October 1,

1974, an additional four charges under Section 324(1)(b), Criminal Code were laid together with seven charges under Section 110(1)(c), Criminal Code—Government Official Accepting Reward.

2. On October 21, 1975, the Preliminary Hearing was completed at which time Mr. Horsfield was committed to stand trial on all but two of the charges under Section 110(1)(c). The date of November 29, 1976 has been set for trial.
