McDONALD ROYAL COMMISSION—INQUIRY RESPECTING OPERATION DIRECTED AT CHINESE EMBASSY IN OTTAWA

Hon. Elmer M. MacKay (Central Nova): Mr. Speaker, I am delighted to see my friend, the Solicitor General (Mr. Kaplan), here in the chamber this evening to deal with this particular matter on the adjournment debate. As the House may recall, this question was asked of the Solicitor General just a few days ago. It was pursuant to a notice I had given him on March 23 that I would ask him a question about a rather interesting operation which was carried out by the security service sometime ago against the People's Republic of China embassy.

The reason I felt after these years that it would be an interesting thing to bring out is that I felt sure the McDonald commission of inquiry and, indeed, the security service itself would probably be interested in seeing what lessons, if any, were learned from this Keystone cops operation, which had as its ultimate absurdity the then secretary of state for external affairs having to call John C. Doyle, who at that time was embroiled in some serious disputes with the Government of Canada, begging him, please, to keep quiet about this particular incident he and his employee discovered.

I am interested to know whether in this particular context the McDonald commission was apprised of this and whether, of course, there were other implications arising from it. Much to my surprise, the Solicitor General indicated that despite my notice, he knew nothing at all about it. I wonder how many files of this particular nature there are.

However, apart from that, I am interested in pursuing another aspect of the hon. minister's answer because in his reply he said to me that it is a matter of public record that the McDonald commission has been given full access to all the records of the security service of the RCMP and the whole of the RCMP.
