Mr. Clarke-On Monday next-INQUIRY OF MINISTRY-What sums have been paid out to date in connection with the taking of the recent census of the Dominion ?

Mr. Charlton—On Monday next—That this House is of the opinion that Canadian import duties should be arranged upon the principle of reciprocity in trade conditions so far as may be consistent with Canadian interests; that a rebate of not less than. 40 per cent of the amount of duties imposed, should be made upon dutiable imports from nations or countries admitting Canadian natural products into their markets free of duty; and that the scale of Canadian duties should be sufficiently high to avoid inflicting injury upon Canadian interests in cases where a rebate of 40 per cent or more shall be made under the conditions aforesaid.
