





PROFESSOR DECLARES HE HAS NOT SOLVED TRANSMUTATION RIDDLE

Experiments Conducted Were Along This Line But Not Wholly Successful.

London, Dec 10 .- Professor Ruther ford seen at Cambridge yesterday, said he could not understand how Le Matin's story originated. He delivered a lecture last May before the Boyal institution, in which he related certain results he had obtained in experimenting by firing radium-electrons into other substances in an endeavor to break up those other substances. That was all there was to it, and though the correspondent gathered the idea that Rutherford had presumably continued his experiments, nothing had developed that he was ready to talk about. In fact, Prefessor Rutherford said he had not talked on the subject at all.

A Paris dispatch on December 8 quoted the Matin as saying that Sir Ernest Rutherford of the University of Manchester, had solved the riddle of transhutation of matter, the secret sought by the ancient alchemists.

less fortunate commands public attention, This young and astute mayoralty candidate reveals in his platform of advanced policies a thorough knowledge of the requirements of the city, and a genius for constructive effort that commends him to the electors as one in whom they would do well to place their confidence.

The world, particularly during the war period, has been impressed by the fact that the man or woman of intensive training is the person to whom the lucrative plums of life's occupations are given.

The boy or girl, however ambitious, who, more through fault of an antiquated system than any of his or her own, embarks on life with lack of education, is almost of a certainty foredoomed to play the role

of subordinate for life. In the face of such conditions the problem is one that must be grappled with in the interests of justice and democracy, and it is well that Ald. Little has had the courage and initiative to undertake the task.

Educational statistics in London tell a story of compelling interest. Education in the primary schools is unhampered by any fee system, and practically every boy and girl completes the course up until the examinations for entrance to the Collegiate. No fees are charged during the first year there, and attendance is fairly representative. The parents of approximately 600 follow commercial occupations, but there are 323 sons and daughters of men following various trades, and 50 sons

and daughters of laborers. But in the second and subsequent years fees are charged, the cost of textbooks advances, and in consequence fewer than 60 students of nearly 400 who commence Collegiate Training are able to finish their studies.

The ambitious boy or girl is restrained by the hardships the cost of education imposes on parents already burdened by the cost of living, In the words of an ex-president of the Trades and Labor Council, who deciares that the workingman should "Hold up both hands for

Little's grand plan," the fees and costs of text books now force father

and mother to go without too much.

University training is of course now largely the preserve of the wellto-do, and automatically the highly-paid positions in life very often

become class monopolies because knowledge is the door to them. Ald. Little's proposal to abolish fees in the Collegiate Institute, with the plan for free text books, will bring the son and daughter of the

workingman to the door of the university. But even there he does not propose to abandon the student, He advocates payment by the city of the tuition fees of all London boys and girls attending Western University if their parents or guardians are assessed on the city rolls for no greater amount than \$3,000 in real estate or income. This scheme is as original as it is certain

to be effective. With Ald. Little in the mayor's chair, its adoption need cost the taxpayer nothing. His plans for increasing efficiency and economy in municipal administration will furnish the solution. That done, every boy and girl in London, be he or she the child of

Ald. Little will bring to the mayor's chair a thorough knowledge of the city's requirements, and a capacity for effecting reforms, such as has made a model to the present time the administration of his
