Descended from the Charltons, of Northumberland, England. Father came from Northumberland, 1824. B. near Caledonia, N.Y., 3 Feb. 1829. Ed. in N.Y. Came to Can. with his family 1849, from Cattaraugus Co., N.Y. Engaged in business at Lynedoch, Co. Norfolk, in 1853, and has continued to reside there. M., Nov. 1854, in Can., Miss Ella Gray. A timber dealer, and engaged in business in Can. and Michigan. First returned to Parlt. for present seat at g.e. 1872; re-elected at g.e. 1874, and g.e. 1878, and again at last g.e. A Liberal.—*Lynedoch, Ont.*

CIMON, SIMON XAVIER. (*Charlevoix.*)

Third s. of the late Hubert Cimon, Esq., Merchant, Murray Bay, P.Q. B. there 3rd Dec. 1829. Ed. in Quebec. M., 9th Nov. 1848, Marie Claire, dau. of the late Pierre Garon, Esq., M.P., of Rivière Ouelle. A Contractor, and built the Provl. Parlt. Buildings in Quebec and other works. First returned to Parlt. for present seat at g.e. 1867, defeated at g.e. 1872. An unsuccessful candidate for same seat in Leg. Assem. P.Q., at g.e. 1875, and again in 1879 on the death of the sitting mem., Mr. P. A. Tremblay. Elected 19 March 1881, on Mr. Perrault being unseated by the judgment of the Supreme Court. Re-elected at last g.e. A Conservative.—*Murray Bay, P.Q.*

COCHRANE, EDWARD, J.P. (*East Northumberland.*)

S. of James Cochrane, a native of Yorkshire, Eng., by Mary Davis, a native of Wexford, Irel., who both settled in the Township of Cramahe, Ont., in 1821. B. there 1 Jan. 1834. Ed. at Colborne, Ont. M., 1st, 5 Aug. 1856, Miss Mary Hicks, (she d. 3 July 1872); 2ndly, 26 April 1876, Ellen Louisa, dau. of Stephen Thorne, Esq. Is a farmer. Has filled all the Municipal positions in the Township of Cramahe, and was Warden of the United Counties of Northumberland and Durham in 1880. First returned to Parlt. at
