TIRE. BOARD OF REVIEW'S DECISIONS. New York, May 9.—One of the principal cases which came before the board of review of the National Trotting Association in session here today was that of Frank Doble, who was accused of having pulled the lever, Art was accused of the second heat, which he lost. Doble said that while the gelding won the first heat easily, he showed temper and sulking in the second heat, which he lost. Doble said the judges accused him of pulling, and suspended him for twelve months, but reinstated him the following day. The board of review decided that Doble would remain suspended for twelve months, beginning Oct. 1. Dennis Harrington, of this city, was accused of pulling, and was suspended for six months, beginning Oct. 1. Wilson, of Dushville, Ind. He testified that he bought the mare Ruellea as a 2-year-old at a sale at Madison Square Garden in November, 1899. The animal was accredited with a record of 2:25 1/2 in the catalogue, and he lost his record on this account. After putting the mare in training, Harrington found that the best he could do was 2:30, and he said that the record in the catalogue was a false one. The decision of the board of review was that the National Trotting Association would instruct its associate managers to have no further dealings with Wilson.

GOLF. DATES NOT YET ACCEPTED. London, May 9.—The Oxford-Cambridge golf club has declined to accept the invitation of the United States and Canada before the meeting of March 30. Consequently the committee has not accepted Sept. 2 as the date for the meeting with Harvard and Yale, nor Sept. 7 for the meeting at Montreal with the McGill and Toronto University teams, as published. It seems quite probable that the original proposal for a meeting at the end of July will find favor.

ATHLETICS. THE AMATEUR CHAMPIONSHIP. London, May 9.—The amateur golf championship opened yesterday at St. Andrews in threatening weather, and with cold wind blowing. The entire numbering 116, are the largest in the history of the competition. The known amateurs are competing. H. H. Hilton, of the Royal Liverpool golf club, is the champion, and is expected to retain the title. He won his first match easily against G. F. Smith, by five up and three down in the first day's play, and the only surprise was the defeat of Mr. C. F. Whigham by James Robb by six up and three to play.

YALE AND HARVARD. Atlantic City, N. J., May 9.—Yale and Harvard met yesterday on the North-field links to contest for the Ardsley cup, the trophy emblematic of the inter-collegiate golf championship of the United States. Each team won its opening match with such ridiculous ease that a true comparison of the relative strength of yesterday's contestants could not be given. The match was at 35 holes.
