"an undivided interest in the property of the club," which could be disposed of by "lot or chance." Protection was claimed under subsection 6 of section 236 of the code. Crown Attorney Smith argued that the promoters were liable, in that they had sold the tickets to the mer-chants, which they subsequently dis-tributed. He claimed that the scheme was one of "clever lawyers to avoid

Many thousands of tickets have been signed and deposited in boxes since the scheme was started several weeks ago, and the decision of the county judge is being awaited with
