Leases for Mines of Gold, Silver, Coal, Iron, Copper, Lead, Tin

TITLES GIVEN DIRECT FROM THE CROWN, ROYALTIES AND RENTALS MODERATE:

GOLD AND SILVER.

Under the provisions of chap..., Acts of 1802, of Mines and Minerals, Licenses are issued for prospecting Gold and Silver for reterm of twelve months. Mines of Gold and Silver, are laid off in areas of 150 by 250 feet, any number of which up to one handred can be included in one License, provided that the length of the block does not exceed twice its width. The cost is 50 cents per nea. Leases of any number of areas are granted for a term of 40 years at 52.00 per area. These leases are forfeitable if not worked, but advantage can be taken of a recent. Act by which on payment of 50 cents annually for each area contained in the lease it becomes non-forfeitable if the labor be not performed.

Licenses are issued to owners of quarts crushing mills who are required to pay

Royalty on all the Gold they entract at the rate of two per cent, on smelted Gold valued at \$19 an ounce, and on smelted gold valued at \$18 an ounce.

Applications for Licenses or Lesses are receivable at the office of the Commissiones of Public Works and Mines each week day from to a.m. to 4 p.m., except Saturday, when the hours are from to to to. Licenses are insued in the order of application according to pitority. If a person discovers Gold in any part of the Province, he may stake out the boundaries of the areas he desires to obtain, and this gives him one week and twenty-four hours for every 15 miles from Halifax in which to make application at the Department for his ground.

MINES OTHER THAN GOLD AND SILVER.

Licenses to search for eighteen months are issued, at a cost of thirty dollars, for minerals other than Gold and Silver, out of which areas can be selected for mining under lesse. These leases are for four renewable terms of twenty years each. The cost for the first year is fitly dollars, and an annual rental of thirty dollars secures each lease from liability to forfeiture for non-working.

All titles, transfers, etc., of minerals are registered by the Mines Department for a nominal fee, and provision is made for lessees and licensees whereby they can acquire promptly either by arrangement with the owner or by arbitration all land required for their mining works.

The Covernment as a security for the payment of royalties, makes the royalties first lieu on the plant and fixtures of the mine.

The unusually generous conditions under which the Government of Nova Scotia grants its minerals have introduced many outside capitalists, who have advays stated that the Mining laws of the Province were the best they had had experience of.

The royalties on the remaining minerals are: Copper, four cents on every unit; Lead, two cents upon every unit; Iran, fire cents on every ton; Tin and Precious Stones; five per cent; ic 2011, to cents on every ton sold.

The Gold district of the Province extends along its entire Atlantic coast, and varies in width from 10 to 40 miles, and its markets an area of over three thousand miles, and its traversed by good roads and accessible at all points by water. Coal is known in the Counties of Cumberland, Colchester, Pictou and Antigonish, and at numerous points in the Itland of Cape Breton. The cress of Iron, Copper, etc., are meet at numerous points, and are being rapidly secured by miners and investors.
