

The Clerk of the House laid on the Table the following Private Bill:—

Bill No. 33, An Act respecting The Montreal Central Terminal Company.  
—*Mr. Bell (St. Antoine).*

The said Bill was read the first time and ordered for a second reading at the next sitting of the House, pursuant to Standing Order 102.

Mr. Cahan, a Member of the King's Privy Council, presented,—Return to an Order of the House of the 17th February, 1932, for a Return showing:—

1. What Federal Public Works in Shelburne-Yarmouth were constructed or undertaken by the Government to be paid for out of the money voted last Session under the moneys authorized to be expended under the Unemployment Relief Act of the last Session.

2. Amounts authorized in respect of each work.

3. Names of the foremen employed in respect of each work.

4. On whose recommendation the selection was made of men to be given employment in connection with each of these respective works.

5. Approximate expenditure actually incurred in respect of each of such works.

6. Whether any such works are as yet unfinished, if so, which of such works.

7. On whose recommendation the Government decided on the authorization of each of the works referred to.

Also,—Return to an Order of the House of the 11th February, 1932, (a) For a statement detailing the different amounts of money given or loaned by the Dominion Government to each of the several provinces during the present fiscal year 1931-32, specifying dates in each case; (b) the specific purpose for which each amount of money so given or loaned was intended; (c) any record or information possessed by the Government in regard to the disposition of each of the said sums, explaining in detail the purpose or purposes for which each amount was expended.

Also,—Return to an Order of the House of the 22nd February, 1932, for a copy of all correspondence, papers and documents in the possession of the Government relating to the fatal shooting of Mrs. Sophie Light of Des Moines, Iowa, U.S.A., by Constable Pirt, R.C.M.P., of Yorkton, Saskatchewan, at a picnic held a few miles from Roblin, Manitoba, on Labour Day, Monday, September 1, 1930; and also of correspondence between the Attorney General of the Province of Saskatchewan and the Minister of Justice of Canada relative to the payment of \$500 to the husband of the said Sophie Light.

Also,—Return to an Address to His Excellency the Governor General, of the 2nd March, 1932, for a copy of all orders and regulations of the Governor in Council made under the Act, Chapter 58 of the Statutes of Canada, 1931, for relieving distress and providing employment.

Also,—Return to an Order of the House of the 2nd March, 1932, for a copy of all correspondence including telegrams, and other documents in connection with the appointment of a caretaker for the post office building at St-Pascal, Kamouraska county, Quebec.

Also,—Return to an Address to His Excellency the Governor General, of the 2nd March, 1932, for a copy of all orders and regulations of the Governor in Council made under the Act, Chapter 58 of the Statutes of Canada, 1931, for the maintenance of peace, order and good government throughout Canada.
