Mr. CASGRAIN: A post office has not yet been opened at Wrentham, and therefore the office has not been closed. Complaints were made against the person nominated as postmaster; but on inquiry no evidence was adduced to sustain the charge, and shortly afterwards he left the locality. Another nomination has been made, and the office will be opened immediately.

2. The Government have paid \$10,000 to the mother of Walter Smith, and \$5,000 to Charles Dorsch as an act of grace for the shooting which occurred at Fort Erie on the 28th December, 1914. The sum of \$2,250 has been paid for legal and other expenses incurred by the parties.
