WAR APPROPRIATION BILL

PROVISION FOR GRANTING TO HIS MAJESTY AID FOR NATIONAL DEFENCE AND SECURITY

The house resumed from Monday, May 29, consideration in committee of a resolution to grant to His Majesty certain sums of money for the carrying out of measures consequent upon the existence of a state of war—Mr. Ilsley—Mr. Bradette in the chair.

Mr. TUSTIN: Will the parliamentary assistant be good enough to give a breakdown of this amount?

Mr. D. C. ABBOTT (Parliamentary Assistant to the Minister of Finance): The breakdown is:

Mr. TUSTIN: How many employees are working under the wartime prices and trade board? How many offices are there across Canada; how many employees are there on the inspection staff, and how many are on

Mr. ABBOTT: As at March 31, 1944, there were 5,112 employees. These are paid employees. There are fourteen regional offices and about 114 or 115 local offices.

Mr. TUSTIN: How many are employed as inspectors?

Mr. ABBOTT: I have not that information at the moment but I will make a note of the question and get it later. In order that I may be clear as to what is meant, does my hon. friend mean enforcement inspectors or some other type of inspector?

Mr. TUSTIN: I think it is the enforcement inspectors. There are a great many of them travelling all across the country.

Mr. ABBOTT: I am advised there are between three and four hundred.
