FIRING OF A.B.M. WARHEADS OVER CANADIAN TERRITORY—MOTION TO ADJOURN UNDER STANDING ORDER 26

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): Mr. Speaker, I ask for leave, seconded by the hon, member for Winnipeg North Centre (Mr. Knowles), to move the adjournment of the house under Standing Order 26 for the purpose of discussing a specific and important matter requiring urgent consideration, namely the urgent situation revealed by the United States defence department that the United States is now seeking Canadian approval to fire anti-ballistic missiles with large thermonuclear warheads over Canadian territory. It is quite clear from the Prime Minister's statements in the house on Monday and statements by Canadian embassy officials in Washington that the United States in deciding to construct this new A.B.M. system did not seek or obtain the Canadian government's permission for such thermonuclear missile flights over Canada, which means that interception would take place over Canadian territory causing extensive nuclear fallout.

Given this fact, plus the broader world danger implications that the construction of this A.B.M. system will further escalate the nuclear arms race, and given the fact that the Prime Minister will be meeting the President of the United States on Monday and Tuesday of this coming week, it is extremely important and vitally urgent that there be a full and comprehensive discussion in the House of Commons prior to this visit in order to evaluate Canada's position in this matter.
