BELL CANADA RATE INCREASES—REQUEST FOR GOVERNMENT ACTION TO RESCIND

Mr. David Lewis (York South): Mr. Speaker, I have a question for the Minister of Communications on a subject on which I have asked him questions formerly. In view of the fact that the increase in Bell Telephone rates came into force today, I want to ask the minister whether he has completed the study of this matter which was considered by the Canadian Transport Commission—he said he was making a study some time ago—and whether he has made a report to the cabinet asking for action to be

taken to stop this totally unjustified gouging of the public?

Hon. Robert Stanbury (Minister of Communications): Mr. Speaker, I could not reach a conclusion as readily as the hon. member seems to be able to. I am still awaiting the report to which he refers. He may have heard the same news report as I did, that a citizen has apparently taken steps to obtain a judicial review of this decision, as is the right of any citizen, including the hon. member.

Mr. Howard (Skeena): Or the responsibility of the government.

Mr. Lewis: Mr. Speaker, in view of the fact that a citizen taking an appeal to a court, with all the steps and all the financial costs that are involved, is not likely to end this unfair increase for a long time, may I ask the minister whether he would undertake to give serious consideration to acting on his own motion or to the government acting on its own motion, as it has the authority to do under a section of the National Transportation Act, to rescind the decision of the commission?

**Mr. Stanbury:** I have said that I am doing exactly that, but I will not jump to a conclusion without analysis as the hon, member has.

**Mr. Lewis:** Mr. Speaker, if the minister was as concerned about the customers of Bell as he is to be smart he would do something.

Mr. Speaker: Order, please.

Mr. Lewis: I have analysed the situation.

Mr. Stanbury: I hope I will have the opportunity to be as smart as the hon. member after the study has been completed.

**Mr. Speaker:** Order, please. I am hoping that both the minister and the hon. member will return to questions and answers.

BELL CANADA RATE INCREASES—REQUEST THAT APPELLANT, DR. LLOYD BROWN-JOHN, BE PROVIDED WITH COPY OF TRANSCRIPT OF PROCEEDINGS

Mr. David Lewis (York South): Mr. Speaker, I want to ask the Minister of Communications a question arising out of the fact that Dr. Lloyd Brown-John of the University of Windsor has in fact taken an appeal which has already cost him personally \$250 to launch. Would the minister consider obtaining for Dr. Brown-John a copy of the transcript of the proceedings before the commission which would otherwise cost him \$1,750?

Hon. Robert Stanbury (Minister of Communications): I will be glad to give consideration to that. I would point out to the hon. member, however, that this Parliament has provided procedures for the consideration of appropriate rates, and I do not think that a minister should abruptly come to a conclusion to interfere with the decisions of the commission without thorough consideration. I am quite willing to consider all the suggestions the hon. member has made, and I will be in a position to make a statement about the matter shortly.
